The Parties agree to the following:

- 1. The referral fee shall be \$500 per group booking. Subsequent sales of goods or services to the referred customer shall also be subject to a referral fee for a period of two (2) years from the initial referral except where such subsequent purchase(s) is for a different service than the initial referral.
- 2. Upon confirantion of a group booking, the referral fees shall be due. The Compnay shall issue an invoice to the Outfitter and payment shall be effected within thirty (30) days of submission of said invoice.
- 3. Placement of advertisements and referral methods for the Outfitter are at the sole discretion of the Company. However, in order to solicit sales, the Company shall not make promises or issue any warranty either expressed or implied pertaining to the goods or services offered by the Outfitter unless authorized in writing by the Outfitter to do so.
- 4. The Company may make use of the Outfitter's trademarks for the sole purpose of promoting the Outfitter's goods or services. Any such use shall be in accordance with the Outfitter's trademark policies. It is expressly understood that this referral agreement does not grant the Company any interest

in the Outfitter's trademarks or any other intellectual property rights.

- 5. The relationship between the parties shall at all times be that of independent contractors. No employment, partnership or joint venture relationship is formed by this referral agreement and at no time may the Company position itself as affiliated to the Outfitter, except as an independent referrer. In view of this independent relationship the Company shall not enter into any agreements on behalf of the Outfitter, shall make no warranty either expressed or implied on behalf of the Outfitter and shall not incur any expenses on behalf of the Outfitter.
- 6. The Company will portray the Outfitter on websites and other appropriate promotional materials as an "Approved Outfitter".
- 7. The Company may do follow-up enquiries with its referred customers to confirm their purchase and to gather feedback about their experience with the Outfitter's goods or services as supplied. Should experience as reported by referred customer be summarily unsatisfactory, the Outfitter may be removed from the program as an "Approved Outfitter".
- 8. Either party may terminate this referral agreement at any time by giving the other party ten (10) days prior written notice. Upon termination by either party all outstanding referral fees due to the Company at that time shall be settled in full within thirty (30) days.
- 9. Each party shall indemnify, defend and hold the other party (and any other relation to the other party) harmless against any and all claims of whatsoever nature arising from misrepresentation, default, misconduct, failure to perform or any other act related to this agreement.
- 10. This agreement constitutes the whole agreement between the parties and any alteration must be in writing and signed by both parties.
